

# GRADUATE COUNCIL MINUTES

February 24th, 2025

The Graduate Council met in person on Monday, February 24th, 2025, at 2:00 pm in Room #584, Close-Hipp Building.

- 1. Call to Order and Approval of Agenda (Terrance McAdoo, Chair) The meeting was called to order at 2:00p.m., and the Agenda was approved.

## The minutes from December were unanimously approved.

3. Report of the Chair (Terrance McAdoo)

Dr. McAdoo welcomed everyone to the meeting and asked that during these unprecedented times to "Let no man pull you low enough to hate him" in the words of Dr. Martin Luther King. Please keep this in mind as we move forward in these uncertain times.

4. Report of the Dean of the Graduate School (Ann Vail)

Dean Vail welcomed everyone back and wished everyone a Happy New Year with this being her first opportunity to do so since we did not meet in January.

Dean Vail introduced Dr. Lingyu (Lucy) Yu, the new Associate Dean for Academic Affairs and Student Engagement, in The Graduate School. She doesn't start officially until May 16<sup>th</sup>. In her new role, Dr. Yu will focus primarily on students and will provide oversight and supervision for graduate

student recruitment, admissions, retention, records, progression, and degree certification. She will advocate for graduate students' diverse needs related to mental health, financial aid and fellowships, professional development, career development and placement. She currently serves as the Associate Dean in the College of Engineering (Molinaroli College) and has a full research agenda there. Dr. Yu will continue her active research agenda and the mentoring of her graduate students at Molinaroli College for the rest of this semester. The program responsibilities that Dr. Murray Mitchell performed have been moved to Dr. Angelina Sylvain.

Dean Vail has been working very hard to keep up with the student requests and graduate faculty appointment requests. Please let her know if you have not heard back on any requests that you have submitted.

The work of the Admissions Systems Optimization Taskforce in association with the Strengthening Graduate Admissions Initiatives that Dr. Sylvain facilitated has been completed. The report is complete and has been presented to the Provost and to the CIO. The Provost has given The Graduate School permission to proceed with the bid process for the graduate admissions system. Once we have direction from Purchasing, we will have a better understanding of the next steps. It appears we will not be able to implement the new system for Fall 2025.

We are rethinking recruitment. Traditional, time-honored recruitment strategies are not as effective as they have been in the past. The Graduate School cannot conduct recruitment in person. With that in mind, The Graduate School convened graduate recruiters from across campus to discuss best practices and how graduate recruiters might collaborate on recruitment initiatives and share resources. Quarterly meetings are planned.

There was some confusion last fall regarding the minimum PhD stipends. With support from the deans, the Provost has moved the minimum PhD stipend to \$21,000 for academic year 2025-26. If your budget allows, please consider a higher stipend as well as increasing stipends for master's and other doctoral students.

The final deadline for Presidential Fellowship nominations is March 7th. To date, nominations are down. While we have strong nominees, we want to make sure we consider all qualified incoming doctoral students. Dr. Goldsmith will present more information on the Presidential Fellowships.

ProQuest is the depository for our dissertations and theses. This year there were two students who had never heard of ProQuest and didn't know that they had to submit their documents. Please remind major professors and graduating students in your colleges that submitting their thesis or dissertation to ProQuest is a requirement. Details about submission and approved templates are available on The Graduate School's website. Students will not be cleared for graduation until these steps have been accomplished.

Related to ProQuest, the Embargo Policy for theses and dissertations has been modified and expanded. New information will be available on The Graduate School website next week. The main changes address the need to expand what type of information is eligible for embargo and how Controlled Unclassified Information will be handled. The expansion will include students who are dealing with politically sensitive issues that would jeopardize their safety. We anticipate having to deal with classified information next. We have also expanded it to include some of the literary projects that are awaiting publication. Please review and share this information with your colleagues.

The Graduate School is developing an introductory course for incoming graduate students that focuses on orientation and graduate student success during their first semester. An advisory committee is

working on this effort. This course model will be structured like that of University 101. Some of our peer institutions have begun to require this course for their incoming graduate students as part of the whole graduate student success. We need feedback from you regarding several issues:

- 1. Instructor: faculty or peer graduate student
- 2. Team teaching with faculty and a peer graduate student
- 3. # of credits
- 4. Length semester or accelerated
- 5. Tuition

If you have thoughts, please share them with her or Dr. Matt Klofenstein who is leading this for The Graduate School. This course will include some orientation, but they really want to teach to those outcomes that determine students' success. They hope to have this pilot available for Fall 2025.

Harlan Smith, Director of International Student and Scholar Support, shared data comparing international enrollment from Spring 2024 to Spring 2025. In addition, he advised about Executive Orders regarding international students and international travel. Mr. Smith stressed that it is imperative that professors do not advise international students about international travel, and they should not put anything in an email. He is happy to meet with your students at his office. His report and advisories are attached for your information and convenience.

# 5. Report of the Graduate Student Association (Md. Ariful Islam Sanim)

- 58 attendees, 14 returned Survey (Finances and Basic Needs were top priorities, GS STUDENTS listed topped how they learned about the event, Swag options: USB sticks and stickers were top, Food and Location were top attracting features, Overall rating: 8.64)

- Grad Student Panel: 2/24 (tonight), for undergrad students, some GSA Cabinet secretaries signed up

# Graduate Student Stipend Concern

- A concern was raised regarding the financial difficulties of surviving on the current ninemonth stipend of \$20,000.
- Fellowships
  - Updated from GC about minimum stipend increases in Presidential Fellows and other scholarship holders
  - Number of scholarships: increase, decrease, or stay the same

- Discussion on creating an official document for PhD students to reference.
  - This document aims to provide clarity on essential policies and resources.
  - Streamline the contractual processes for graduate employees, including clarity on [Dean Vail follow-up]
  - Delineate minimum pay based on program/degree and its duration, and options for summer funding if not in the contract.
- Professional development reimbursement lags from the Finance team.
  - Workplace conditions such as access to desks, monitors, workstations, and buildings/labs are uncertain.
  - Policies for in-person versus remote work expectations.

# 6. Report of the Academic Policy and Practices Committee (Bill Hauk)

Dr. Hauk shared that after meeting a few times with his committee on the different classifications of graduate faculty and possibly suggesting some revisions to the Faculty Manual. One big issue is clarifying graduate faculty who are not doctoral degree holders and what different responsibilities they might have vis-a-vis supervision of graduate projects (serving on dissertation committees and not possessing a PhD themselves). This Committee has also been tasked with coming up with a plan on how to treat the emeriti faculty and other faculty who have voluntarily left the University while they were graduate faculty and members of various committees. They want to come up with a way to streamline the process that would allow them to continue to serve on students' committees. He circulated a draft to change the language in the Faculty Manual to his committee over the weekend; so,

they have not had a chance to meet and discuss. He will share their draft suggestions with the Graduate Council at our next meeting.

Dean Vail requested approval for Dr. Sheri Silfies to remain as a Major Professor following her departure from the University of SC for another university. She has five students that she would like to remain on their committees until they graduate. A Council member made the motion, and it was seconded for the approval of a term appointment to allow Dr. Silfies to remain as a major professor on these students' committees. The Chair and the Graduate Director of the Department of Public Health have approved of Dr. Silfies' request.

# 9. Fellowships and Scholarships Committee (Edie Goldsmith)

Dr. Goldsmith reported that the Presidential Fellows committee has completed the first round of nomination reviews. There were 17 submissions, one later withdrawn; so, the committee evaluated 16 nominations. We identified the top 6 which were recommended to Dean Vail for funding. We expect to be able to fund 10 to 12 fellowships this year. It was noted that first round nominations decreased compared to last year--potentially due to the increase in required stipend support. The second round of Presidential Fellowship applications and Rhude Patterson nominations are due on March 7th. Trustee fellowships for continuing students are due on March 17th.

The letter raised two primary concerns: first, regarding the proposed titles of courses HSPM 810, 811, 812, and 813; second, related to the removal of an introductory statistics course as a prerequisite within this series. The committee chair provided feedback regarding the timing of communication of these concerns, noting that extensive efforts had been made within the Arnold School of Public Health to coordinate and gain consensus across departments on the proposed course language and content over the course of the past couple of months. Ultimately, after Council discussion, the courses were put forth for a vote with their original titles and were approved.
