

### **GRADUATE COUNCIL MINUTES**

### March 24th, 2025

The Graduate Council met in person on Monday, March 24th, 2025, at 2:00 pm in Room #584, Close-Hipp Building.

- **1.** Call to Order and Approval of Agenda (Terrance McAdoo, Chair) The meeting was called to order at 2:02p.m., and the Agenda was approved.

- 4. Report of the Dean of the Graduate School (Ann Vail)

Dean Vail will be sending an email to the deans of the colleges of the members whose Graduate Council membership terms expire at the end of this semester. The departments are as follows: Music, Pharmacy, Education, Medicine, Arnold School of Public Health, and Arts and Sciences. We will calculate enrollment in your colleges to determine how many representatives each college will have according to the formula. If your department has more than 400 students, an additional representative on Graduate Council is allowed.

To date, we have received over 11,000 applications with 67% of them from international students. We have received decisions on about 5700 applications with about 5400 applicants still waiting for decisions. Please encourage your units in your colleges to speed up this process. We know from the past few years that 80% of the students select the first school that admitted them. We want the University of South Carolina to be that first school. Our next challenge is to convert them into enrolled students. One way the Graduate School is working to increase yield is by holding an "Admitted Graduate Students Week". Throughout this week, we are presenting a total of 8 webinars starting this evening. The webinars are titled:

- Count Down Columbia
- Managing Your Time
- USC Career Services
- Question and Answer with International Student and Scholar Support
- The USC Graduate Student Experience
- Planning for Success at USC
- Thriving as an Online Student
- Grad Chat

We are still committed to offering Grad Launch, led by Dr. Matt Klopfenstein, as an onboarding orientation course this Fall as a pilot. We haven't made final decisions about this course yet, but we are anticipating an accelerated 1 to 2 credit course each semester for first semester students only to get them onboarded and connected while trying to reduce social isolation among incoming students. Please encourage your students to participate. We are partnering with International Student and Scholar Support. Please give her or Dr. Klopfenstein your thoughts. Class size will not exceed 20. The goal is to pilot 1 to 2 sections in the Fall.

The Office of Student Advocacy helps students resolve university-related problems and concerns in an informal way. Students should seek help from this office when they:

- Need help certifying an excused absence
- Don't know where to go or whom to ask about an issue
- Feel they have been treated unfairly by faculty or staff members
- Are unsure about how to navigate university policy or procedure

You are encouraged to refer your students to the online referral to the Office of Student Advocacy. In January and February there were a total of 67 referrals with the most being academic issues. This number is higher than it was in the entire Fall semester.

The Doctoral Hooding schedule is different this semester. Doctoral Hooding will be held May 8<sup>th</sup> at 9 am—not 10 am.

As a reminder, the Provost has moved the minimum PhD stipend to \$21,000 for academic year 2025-26. Please make sure that your financial staff is aware of this increase before GA hires are submitted for approval for the Fall semester.

Applications are now open for the in-person Dissertation Writing Academy to be held May 13-30 and the Online Dissertation Writing Academy to be held June 9-27. The online academy will be limited to online students only. We currently have 13 applications for the in-person academy and 6 applications for the online academy.

Harlan Smith, Director of International Student and Scholar Support (ISSS) shared that no clarification of Executive Orders has been received regarding international students and international travel. The number of countries with travel bans has increased from 41 to 43. He and his staff are happy to speak with your students in the office of ISSS or anywhere on campus. They will discuss travel bans, visa aspects, and immigration aspects only.

# 5. Report of the Graduate Student Association (Md. Ariful Islam Sanim)

### **GSA Election:**

On March 8, the Graduate Student Association (GSA) election had a record turnout cast. The election included candidates from the Department of Education, Department of English, Computer Science, Business School, Department of Statistics, and the Law School. ### **DC** Advocacy Trip:

Members of GSA along with Dr. Angelina Sylvain, Dr. Ambra Hiott, and three other cabinet secretaries are going to Washington, DC on April 3 - 5. They will be meeting with federal legislators to discuss top priorities such as funding/stipends, research funding, and access to education.

### **New Initiative:**

A new task force for international students has been created to help strategically coordinate across campus partners about issues international graduate students face. They met on March 20th to talk about housing issues, the visa processes, and the health care system.

# **Grad Student Orgs:**

Funding to Grad Student Orgs (GSOs) has been using up steadily and they currently allocated their full budget and are unable to fund anymore. The internal funding on GSA events/initiatives have been spent conservatively, but they will be sure to use it all with the many upcoming events.

# **Parking and Transportation Townhall:**

Parking and Transportation Townhall (w/ Director of USC P&T Services, and the Exec Director of The COMET-city transport authority). We are now getting email notifications from the USC Parking Department during the game days letting us know where alternate parking is available-- this was not done previously. Additionally, the director of The COMET announced that services on demand will be provided regularly.

# 9. Fellowships and Scholarships Committee (Matt Klopfenstein for Edie Goldsmith)

Dr. Goldsmith was not able to attend the meeting, and Matt Klopfenstein gave an update from the committee on her behalf. The committee is currently reviewing the second round of Presidential Fellowship nominees and will make additional offers soon. 23 nominees were submitted for the second round, for a total of 40 submitted (one withdrawn) for the year. This represents a slight decrease from last year (45 nominations). The committee is also reviewing nominations for the Graduate Student Awards and Trustee Fellowships. A significantly higher number of nominations were submitted for both this year (80 Graduate Student Award nominations compared to 26 last year and 31 Trustee Fellowship Nominations compared to 12 last year). Recipients will be announced at the Graduate School Recognition of Excellence on April 25 as part of Discover USC.
