“ I develop innovative technology-based interventions for cancer decision making and aging in place for people with a variety of health conditions such as Alzheimer’s disease and related dementias. For example, my latest research seeks to refine and evaluate a technology-based remote monitoring system for rural dwelling African-American adults who are suffering from Alzheimer’s or related dementias. We hope that one day we can identify digital biomarkers that can signal us when a person is experiencing cognitive decline and how fast that person’s cognition is declining. Similar technology might also allow a person living with dementia to be able to age in their homes safely by alerting someone like a caregiver or a clinician when a person is experiencing some type of critical health or safety concern. My work is important because it will help improve the quality of life for the 125, 000+ people who are living with this deadly disease. ”




